

## Official Information Request WCDHB 9402

I refer to your email dated 27 February 2020 requesting the following information under the Official Information Act from West Coast DHB.

 The number of sexual harassment reports made by person(s) employed (staff) by the DHB in the calendar years of 2019, 2018 and 2017, broken down by whether they involved either patients or other staff.

Patient on Staff: Psychological Assault / abuse	28	27	8	63
Patient on Patient: Psychological assault	13	23	7	43

**Please note:** that psychological assault / abuse above includes threatening behaviour, harassment and bullying grouped together

No reports were received for the periods indicated for <u>staff</u> perpetuating the above types of abuse on patients.

  - b) Verbal assault/abuse
  - c) Psychological assault/abuse
  - d) Racial assault/abuse;

Made to the DHB in the calendar years of 2019, 2018 and 2017, broken down by whether they were perpetrated by either patients or staff.

We have no record of complaints in our system for the above types of abuse made by patients.

Our staff are encouraged to report **all** incidents. An incident is any unplanned or unexpected event resulting in, or having the potential for harm, ill health, damage, loss or disruption to service delivery. Each event is reviewed so that patients and staff are supported, and secondarily for continuous quality improvement.
