It was confirmed that the Terms of Reference are to inform Tatau Pounamu are therefore not required to be ratified by the Board. No further follow up is needed. To be removed from the action register.

Maori Representative Appointment Requests

Whanau Ora

Further discussions regarding the use of 'whanau ora' in documents and gaining a common understanding of whanau ora within the DHB and broader health context.

There is a Memorandum of Understanding that has been developed between Te Herenga Hauora and Te Putahitanga o Te Waipounamu however this is on hold for now.

Discussions and updates to continue.

DNA Update

Ongoing. Carried over.

There has been a reduction in DNA for Maori. A reduction of 3-4% for the general population. A lot of effort and time gone in to ensuring that the data is accurate.

A member asked if there was any evidence of DNA increasing around travel disturbances due to weather conditions and if NTA (National Travel Assistance) is taken into consideration around flight changes and cancellations and in particular for West Coast appointments.

Improved Access to Hokitika Health Services

A date is to be scheduled over the next couple of months to arrange a forum where the overall health services for Westland can be discussed. At this stage no dates have been confirmed .

Rangatahi

Mokowhiti Consulting through the Kia ora Hauora contract are leading the Rangatahi placement programme that is currently being organised for the West Coast Region in September with assistance from the DHB. Tatau Pounamu are interested in their approach to see how they communicate the programme around the rohe and want to ensure that they are aligned to some of their key networks to enable greater distribution of these opportunities. For example putting a greater effort into targeting the parents of the children within the Rununga networks and working with the leadership initiatives that are delivered through Putahitanga o Te Waipounamu.

A member noted that nothing has been received through the Rununga or through tribal networks about the upcoming placement. There are a number of leadership opportunities happening for rangatahi outside of this programme and where possible it makes sense to tap into youth participating in these programmes – we want all rangatahi to have access to these opportunities.

It was noted that there is a maximum of 10 places on the Rangatahi Placement Programme and it is not possible to increase that number.

ACTION: Mokowhiti to attend next meeting.

Maori Mental Health Kaumatua Appointment

A discussion took place with the Board Chair about exploring the possibility of extending the Kaumatua Cultural support to incorporate support for the entire DHB and not just a focus on Mental Health.

It was confirmed that an update to the Board would be provided and that the intention is to move this discussion forward with a hope of resolving over the next couple of months.

ACTION: A hui to be arranged with Gary, Paul & François to discuss this further.

AGENDA

1. GM Maori Update

Taken as read.

Diabetes – Report tells us that we could be doing better. Discussions have been occurring with Poutini Waiora staff. Gary also mentioned that it is time to start asking some questions about how this condition is manged. The question was raised around the 80% data and has anyone reached the target and could the Whanau Ora navigators be assisting to influence better outcome. Look at the models of care that are being used.

Cervical Screening - End of June result should be better again in terms of Cervical Screening. Poutini Waiora are also assisting to drive this. Targeting a lot harder. Confident it will track in a positive direction.

Long Term Condition Graph – Target is 7.6%, however it isnt' clear on actual numbers. Report shows that 231 Maori are enrolled in the LTC programme which equates to 6.4%.

A general discussion took place about how the PHO targets are addressed in terms of better outcomes for Maori. The main driver of influence needs to be the board – needs to be a whole of system approach. Poutini Waiora is a key component but not the driver, It is an equal partnership.

2. Maori Health Plan Verbal Update - Kylie Parkin

Still with the Ministry but verbal approval has been given.

3. <u>Alliance/Workstream Update - Phillip Wheble</u>

 Ministry of Health System Level Measures – There are some high level measures that the Ministry is talking about and we are looking at our local measures alongside the PHO and DHB and what can be measured monthly. There is a meeting planned for July to discuss. Poutini Waiora will also be included in these measures as well their expectations of delivery against the Maori Health Plan. There will be Maori Representation required at these discussions.

Mark Newsome Grey/Westland Update

- Surgical throughput are behind because of no patients. This Impacts on volumes.
- Medical throughput is up. Model of care is working.
- Outpatients there are fewer follow ups, this is reflective of contempary practice. Rural GP and specilaists are assisting with some of the targets.
- DNA's a sustained decrease since December. A lot of work has been done to see rate come down.
 In April 5.3% month on month decrease for past 6 months. Maori DNA rate is also decreasing in this space.
- Workforce have recruited a clinical nurse specialist for stroke.
- Continuing to identify new graduate nurses within hospital and mental health.
- Recruiting for a rheumatology nurse specialist. An infusion nurse is also looking to be recruited.
- Continuing to recruit for junior doctors. Hopeful of recruiting to full compliment.
- Managed to recriuit to Older Persons Health and Mental Health have a registrar, this is really positive.

- Maternity In April 100% of babies were fully breastfeed. 70 reccomendations have been implemented since the last review and in place and working into business as usual.
- Prime Minister Awards Maternity Services are part of this.
- Reefton Workstream meetings are continuing to be discussed with the Community and what a potential service may look. They are working really positive.
- Buller Palliative care unit is relocated and working well.
- Allied Health Some vacancies. On a recruitment drive for some of these positions.
- Allied Health are also starting to look at telehealth increasingly. Dieticians have just started to use this.
- Health Targets Fancer Cancer Treatements. Increases on all 4 quarters. Low numbers due to not hitting targets.
- Immnunisation Targets hit 89%
- Elective Services continuing to meet our targets. Trans Alpine orthopaiedic services. Reviewing the delivery of trans alpine, 40 years since last put in place.

Community

- Looking at opportunities into the community for primary. Integrated Family Health Service is a model That will support this work.

Hospital Rebuild

- Underway, Fletchers team have been really positive.
- There is a commitment to employing as many people locally as they can.
- Looking to make links with the Polytech and High schools in terms of learning opportunities.

Buller

- Indicative business case is being looked at. Going under the partnership Group.

Mental Health

- The Director of Mental health visited the DHB last week. From December there has been a change in some leadership positions and since then accuracy of reporting has improved. The DHB continues to report bi monthly on the mental health plan.
- Clinical Governance for Mental Health has been reshaped (The Mental Health Governance Group) Dr
 Cameron Lacy DHB Medical Director for Mental Health is taking a lead in this work

The Chair asked about the work of the suicide governance group.

- Suicide Prevention Action Group Signed off by MOH
- Post Vention Group Looking at the suicides on the West Coast and the clustering effect.

The Deputy Chair wanted it to be noted that there was a lack of information provided at the last Tatau Pounamu meeting around the Maori Mental Health update.

ACTION: Invite Dr Cameron Lacey to our next meeting.

4. Community Public Health Update

Taken as read.

The Ministry of Health will visit the region to discuss detail of the newStop Smoking service which will inform the service specification moving forward. The contracted numbers will increase from 100 to 257 with a quitrate target of 50% at 4 weeks. Appetite for Life – A question was raised around other districts involvement with this and how this is delivered across the West Coast and if there is a specific focus for Maori? Kylie responded that this programme is delivered across the West Coast and is delivering at full capacity – Maori

communities are certainly a key priority and engagement with Maori communities has been very positive. Some great work being undertaken by the team at CPH with innovative approaches with pre-schools.

ACTION: Kylie to follow this up with Claire Robertson

Improvng Cancer Pathway for Maori in Te Waipounamu – Dr Melissa Cragg

The project brief was provided to all Tatau pounamu participants for discussion and comment. The purpose of this piece of work is to improve the Cancer pathway for Maori and to improve equity in access to cancer services and in cancer outcomes.

It was confirmed that Dr Melissa Cragg will be on the West Coast in July to begin engagement with key stakeholders.

The Chair asked about the process and opportunity of this work being conducted locallly or from within Poutini Waiora and the importance of having someone who was closely linked into the community? Also a very keen interest to know how engagement will be conducted with whanau. It was advised that this appointment for the work followed a very robustRFP process led by the Southern Cancer Network . The primary focus of the RFP is to determine the pathway from diagnosis, this has been the directive from the Ministry.

The Chair also mentioned that there has been a lot of work done previously in this area and it should be considered in this current piece of work.

ACTION: Invite Dr Melissa Cragg along to the next Tatau Pounamu meeting for an update.

Ministry of Health

Alison Toms has been appointed to the Executive Leadership Team at the Ministry of Health with the Maori Leadership portfolio. She will be presenting at the next Te Herenga meeting. Gary has advised that he will update on her discussion from Te Herenga at the next Tatau Pounamu Meeting.

REPORT to WCDHB TATAU POUNAMU COMMUNITY AND PUBLIC HEALTH (CPH)

October 2016

Nutrition and Physical Activity

CPH have continued to focus on Early Childhood Nutrition by running a workshop in Ahaura (Grey Valley) Playcentre. As part of this work, staff are developing a Healthy Kai for Under Fives workbook. It has become clear that there is a need for a practical resource with more information on the common themes, challenges and frequently asked questions from parents of pre-schoolers.

The West Coast Nutrition Team (members include staff involved in the delivery of nutrition services through CPH, WCPHO and WCDHB), have raised concerns about the apparent increase in food insecurity amongst clients of their services and the wider community. A rapid literature review has been completed by the CPH Information Team on 'Food Security Interventions in New Zealand,' to provide an evidence base about potential interventions to address these concerns and support communities. The group will use this review report as a resource to develop a way forward to help address food insecurity on the Coast.

Collaborative work around nutrition and physical activity has been a key focus for us over the last six weeks. This has included working with the WCPHO's Green Prescription team at the community based Be Active programme, where community nutrition options were discussed and an introduction to Tai Chi was delivered. This resulted in some participants now attending a community Tai Chi class. CPH has also been working with Enviroschools on how to combine messages (e.g. fewer packets = better for the environment and a generally healthier lunch box). As a result we will be attending two meetings/workshops with teachers and parents of primary schools and early childhood centres. CPH staff, alongside Poutini Waiora, also ran two nutrition sessions with the Mana Tamariki mums in Westport. CPH is also working with WestREAP and Cobden School to organise and support the Schools Kapa Haka Competition which will be held at the Regent Theatre on the 22nd of September.

Health Promoting Schools

Over the last three months there has been a focus on workforce development opportunities to address schools' identified needs. Sue Bagshaw, youth health expert, visited Greymouth to help train rangatahi at Grey High School to establish a Youth Health Mentor Group at Grey High School ('Ears for Peers'). HPS will provide ongoing support for this group, linking in with other supportive organisations within the community. Dr Bagshaw also visited Buller to discuss the establishment of a Youth Hub and later delivered a training for professionals regarding alcohol, drugs and young people.

Safeguarding Children training was delivered to Reefton Area School and the wider Reefton community on the 16th August. This training supports schools to be able to identify and respond appropriately to vulnerable children. Lastly, Vic Tamati of the 'It's not ok' campaign visited five schools in the Greymouth region providing an opportunity for both students and staff to learn about the effects of family violence, that it is ok to ask for help, and that change can happen. This was a collaborative response (with the Te Rito Family Violence Network) to a need identified by schools.



Alcohol Health Promotion

CPH has been successful in an application to the Health Promotion Agency Community Action on Alcohol Partnership Fund. This funding will support the delivery of five workshops across the Coast—"Teenagers, Alcohol and the Amazing Brain". The plan is to bring Nathan Mikaere-Wallis to the West Coast to work with the seven secondary and area school communities. The current youth drinking culture has been identified by schools and the wider community as a wellbeing priority. This is part of an ongoing project with schools and communities to talk openly about alcohol and for people of all ages to be much more aware of the harms that are associated with alcohol.

Smokefree Enforcement

As part of our smokefree enforcement work, CPH's Smokefree Enforcement Officer conducted tobacco retailer compliance checks throughout the West Coast in July. Following this, CPH staff conducted a controlled purchase operation of tobacco retailers which involved monitoring a person under the age of 18 as they asked to purchase cigarettes from tobacco retailers in South Westland and Hokitika. Two retailers sold cigarettes to the underage volunteer and both have received formal warnings.

Annual Survey of Drinking Water Quality 2015-16

The period of data collection for the Ministry of Health's Report on Drinking Water Quality (Annual Survey) for the period 1 July 2015 to 31 June 2016 has just been completed. To achieve overall compliance with the Drinking Water Standards for New Zealand (DSWNZ), a water supply must meet the bacteriological, protozoal and chemical standards. The survey includes results for all networked drinking water supplies serving populations of 100 persons or more.

Over the last annual survey year reported transgressions of the DWSNZ which led to temporary boil water notices being issued occurred at the Punakaiki, Taylorville-Dobson, Whataroa, Kumara and Arahura Pa water supplies and these results have been included in the data collected. CPH will be compiling a detailed compliance report on each councils' water supplies over the next six weeks.

Healthy Homes Project in Buller

CPH is working with Poutini Waiora and Community Energy Action to progress the development of a curtain bank in Westport. This will be contingent on finding a suitable space to store, check and distribute curtains to whānau in need.



Accessible Communities

CPH has been working with West Coast Disability Resource Service to organise and promote two Accessible Community workshop days to be held in Greymouth and Westport in early September.
